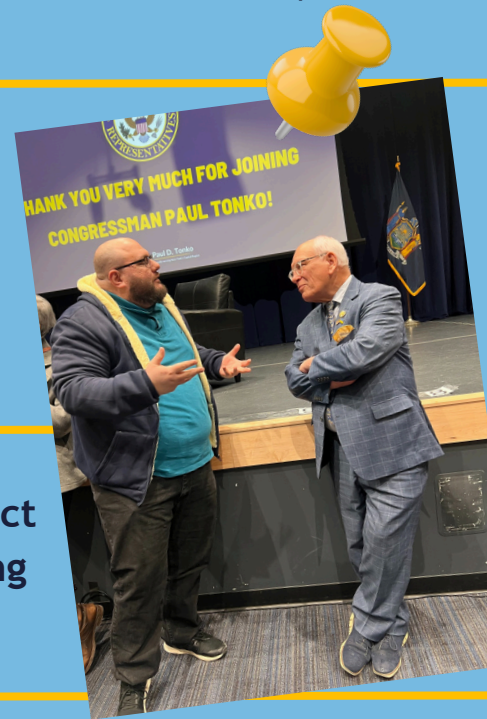

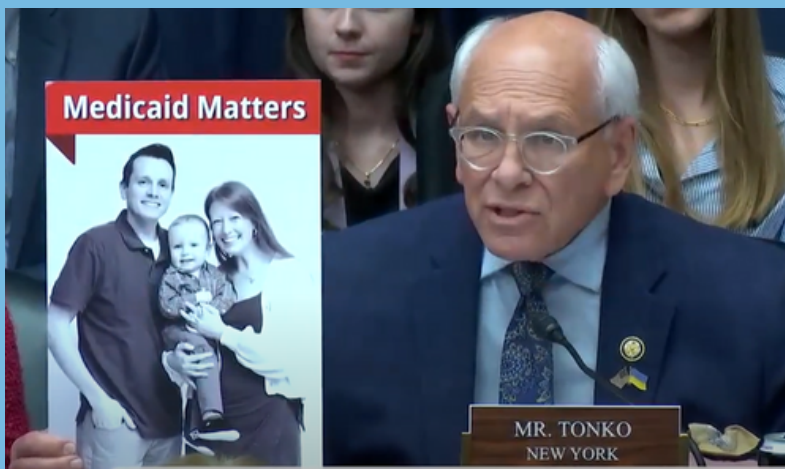
## Introduced 16 bills, including legislation to:

- Protect scientific integrity by establishing clear, enforceable standards for federal agencies and federally-funded research to keep public science independent from meddling by political and special interests (H.R. 1106; 130 cosponsors)
- Empower states to restore Medicaid access for incarcerated individuals reentering society, thereby saving lives and reducing recidivism (H.R. 2586; 80 cosponsors)
- Establish commonsense safety standards on the sports betting industry to protect players, fans, and families from the impact of gambling addiction (H.R. 2087)
- Investing in home weatherization efforts to save families hundreds of dollars on their energy bills while making homes safer, healthier, and more energy efficient (H.R. 1355; advanced through full committee)

**11 bills and resolutions were introduced with at least 1 Republican co-sponsor (>2/3 bipartisan)**

**Cosponsored more than 400 bills**

**Committee/Caucus Work**



Participated in multiple overnight hearings to share constituent stories on why Medicaid matters and oppose the disastrous cuts in the Big Ugly Bill.

Took part in 10 events held by the Addiction Treatment and Recovery Caucus including naloxone trainings, briefings on addiction recovery, roundtable discussions on psychedelic research and more.



# Bringing Federal Dollars to Our Capital Region



Saved nearly **\$81 million** for individuals, small businesses, and organizations seeking federal assistance with the IRS and TAS



Secured **\$3,000,000** in funding for local projects to improve water infrastructure, construct community centers, and support public needs and services



Delivered **\$5.45 million** in federal funding for 11 Capital Region fire departments and EMS squads



Provided nearly **\$32 million** for the Capital District Transportation Authority (CDTA) for the acquisition of **hybrid-electric buses** and new technology systems



Sent **20+ newsletters** sharing grant opportunities with thousands of individuals, small businesses, nonprofits, and more to help secure targeting funding for the district
