### Access to High Speed Internet is Essential

- **Students, teachers, doctors and nurses, entrepreneurs and countless others** across many professions rely on Internet access for work and to communicate with peers and loved ones
- **2.3 million students** in grades K-12 across **more than a quarter of U.S. school districts still lack access to broadband** at federal baseline target speeds
- Nearly 1 in 4 rural Americans don't have access to fixed 25 Mbps/3Mbps broadband

### Widespread Economic & Social Benefits

- Broadband networks provide **more efficient and less costly ways to deliver essential public services** like health care, education, public safety and emergency services
- A World Bank study of 25 countries found that a **10% increase** in fixed broadband expansion caused in an average **increase of more than 3% in per capita GDP**
- \$10 billion invested in new broadband networks would support nearly 500,000 new or retained jobs in the U.S. (<u>ITIF</u>)

# **Congress Can Do Better!**

- > The processes for pursuing and managing federal broadband resources span multiple agencies
- > Without a streamlined system, these resources are uncoordinated and can be difficult to track
- Current investments are made with little accountability and oversight on behalf of taxpayers
- Many local communities and small businesses are not vying for the available funding

#### The ACCESS BROADBAND Act

- Stands for Advancing Critical Connectivity Expands Service, Small Businesses Resources, Opportunities, Access, and Data Based on Assessed Need and Demand
- **Establishes an Office of Internet Connectivity and Growth** at the National Telecommunications and Information Administration (NTIA), **which already has the necessary infrastructure**, resources and staff to oversee and track broadband funding across agencies.
  - Directs this office to simplify access for small businesses and local communities, possibly including small business workshops and other support resources.
  - Streamlines process for small businesses & local governments to apply for federal broadband assistance; improves coordination across government and the private sector.
